**REQUESTED ACTION:**

- 1) Approve the Special Faculty Permit Review Committee's (SFPRC) recommendation for a Special Faculty Permit (SFP) appointment for Karl Peter Lindholm, M.D., Ph.D., pursuant to California and Business Professions Code (BPC) section 2168.1(a)(1)(B).

**BACKGROUND:**

The Medical Board of California (Board) is authorized to issue an SFP to a physician who is academically eminent and meets all the requirements pursuant to BPC section 2168.1.

The SFP authorizes an individual to practice medicine only within the medical school and its affiliated institutions where the SFP holder is providing instruction as part of the medical school's educational program, and for which the medical school has assumed direct responsibility.

The SFPRC is comprised of 14 members: one representative from each of the 11 medical schools in California, one representative from academic medical centers, and two Board members. The SFPRC reviews and makes recommendations to the Board regarding the eligibility of the applicants applying pursuant to BPC section 2168.1(c)(1).

At the SFPRC's September 21, 2022, meeting, the SFPRC reviewed the qualifications of an applicant from the University of California, San Diego (UCSD) School of Medicine. Andrew Ries, M.D., M.D., M.P.H, Associate Vice Chancellor for Health Sciences Academic Affairs at UCSD School of Medicine presented UCSD's request for Dr. Lindholm to receive an SFP. Dr. Ries indicated that Dr. Lindholm is internationally recognized for his clinical and research expertise in radiology and hyperbaric and diving medicine. Dr. Lindholm is also expected to develop a program of research in hyperbaric and diving medicine. Additionally, he will teach students, residents, and fellows in hyperbaric and diving medicine, and may also teach in other areas, such as radiology and physiology.

Dr. Lindholm currently serves as Professor in Residence, Endowed Chair, with the Department of Emergency Medicine and as Adjunct Professor with the Department of

Radiology at UCSD. He has had multiple publications and has received awards due to his research, which exemplify his distinguished academic and professional standing.

If approved for an SFP by the Board, Dr. Lindholm will hold a full-time faculty position as Professor in Residence, Endowed Chair for the Department of Emergency Medicine and Radiology at UCSD School of Medicine.

### REQUESTED ACTION:

### BACKGROUND:

The Medical Board of California (Board) is authorized to issue an SFP to a physician who is academically eminent and meets all the requirements pursuant to BPC section 2168.1.

The SFP authorizes an individual to practice medicine only within the medical school and its affiliated institutions where the SFP holder is providing instruction as part of the medical school's educational program, and for which the medical school has assumed direct responsibility.

The SFPRC is comprised of 14 members: one representative from each of the 11 medical schools in California, one representative from academic medical centers, and two Board members. At the SFPRC's September 21, 2022, meeting, the SFPRC reviewed the qualifications of an applicant from the University of California, Davis (UCD) School of Medicine. Susan Guralnick, M.D., Associate Dean for Graduate Medical Education, presented UCD's request for Dr. Karli Oğuz to receive an SFP. Dr. Guralnick indicated that Dr. Karli Oğuz is internationally recognized for her clinical and research expertise in neuroradiology and pediatric neuroradiology. Her areas of expertise include imaging of epilepsy, autoimmune diseases, neurodegenerative and inherited metabolic diseases, and brain tumors. Elizabeth A. Morris, M.D., Professor and Chair of the Department of Radiology at the UCD School of Medicine recommended Dr. Karli Oğuz's appointment based on her extensive body of work, where she will continue to expand the medical community's understanding of neurological conditions and diseases. Dr. Karli Oğuz is expected to engage in clinical activities in inpatient, outpatient and consults in

neuroradiology, use advanced neuroimaging techniques, cover areas of diagnostic radiology, and develop an independent research program.

Dr. Karli Oğuz is currently a Professor and Chief of Neuroradiology at Hacettepe University. Additionally, she is an Affiliated Professor with the National Magnetic Resonance Research Center at Bilkent University in Turkey. She has engaged in many projects and multidisciplinary research endeavors and has numerous publications and citations of her work, which exemplify her distinguished academic and professional standing.

If approved for an SFP by the Board, Dr. Karli Oğuz will hold a full-time faculty position as a Visiting Professor with the Department of Radiology at the UCD School of Medicine.
