Professional Profile:**Best Start Birth Center Executive Director** (February 2007 to present)

Extensive background in operating a state licensed and national accredited freestanding alternative birthing center. Perform all leadership functions deemed necessary by the Board of Directors to ensure achievement of Best Start Birth Center's goals and execution of its mission. Responsible for the direction, coordination and overall management of facility and implement the objectives set by the Board to ensure the organization's overall effectiveness.

Responsibilities:

1. Coordinates the long-range financial development and management of the center while maintaining quality clinical and personnel services.
2. Institute new public relations tools increasing community interest in the birth center and increasing clientele.
3. Lead participation in grant projects, (Healthy Start and Strong Start), collecting data/evidence demonstrating midwifery led birth centers as a cost effective, high quality model of care. Ensure ongoing data collection for the American Association of Birth Centers utilizing the perinatal data registry.
4. Participate/coordinate selection and training of new management team members. Ensure implementation of center's philosophy and objectives related to staff performance standards, policies and procedures, clinical practice guidelines, job classifications, and compliance with government regulations and credentialing practices.
5. Represents the center in its relationships with other health organizations, government agencies, and third party payers.
6. Continuous quality improvement in the area of personnel work practices for Human Resources, provider credentialing, and Occupational Health/Safety.
6. Responsible for insuring sound ethical practices and strict compliance with all regulatory agencies governing health care delivery and the rules of national accrediting and state licensing bodies.
7. Coordinate with Clinical Director and members of the clinical management team to ensure open lines of communication and collaboration while maintaining strict adherence to policy and procedures of the birth center.
8. Recommend policy positions regarding state and federal legislative matters that allow increased access to midwives and birth center care for California women.
9. Coordinate with medical staff and other center personnel to monitor activities to ensure fulfillment of the community's needs for quality health care: Volunteer doula program, lactation support classes, postpartum support classes, group prenatal appointments for Best Start clients and the public, and access to CPSP, (Comprehensive Perinatal Services Program).
10. Maintains strictest confidentiality. Privacy Officer. Security Risk Analysis.

Accomplishments:

- Instituted new public relations tools increasing community interest in the birth center and bringing in new clientele increasing the number of moms admitted to the birth center. As a result, the overall rate of cesarean sections in San Diego was lowered making a positive impact for San Diego birthing women.
- Best Start was a leading birth center in the CMS Strong Start grant program for lowering preterm birth.
- Effectively negotiated superior professional liability insurance policies at substantially reduced cost, 40% less than previous policy(s).
- Led staff through multiple CABC re-accreditation's. Brought the birth center into electronic health record keeping converting paper charts to an electronic health record system improving procedures for tracking Commission for the Accreditation of Birth Center (CABC) Standards and Indicators.
- Creation of second corporation specific to professional services, (Best Start Midwife Services) distinguishing clinical care separate from facility services, insuring compliance with California Board of Nursing regulations.
- Re-negotiated facility and professional services contracts allowing for significant increased reimbursement from private/public payers. Sought and received increased reimbursement for birth center facility and professional services from Medi-Cal, (California Department of Health Services, (DHCS).
- Worked closely with the American Association of Birth Centers (AABC), and Congresswoman Susan Davis's office to ensure birth centers were reimbursed a facility fee, (H.R. 2358, Medicaid Birth Center Reimbursement Act).

- Worked closely with CA state legislators, house speaker-Toni Atkins on AB1306 and California Nurse Midwife Association, (CNMA) to create bill language that allows increased access to midwives and birth center care for California women by removing physician supervision for Certified Nurse Midwives.
- Created non-profit 501C3, Women's Health International, (womenshealthintl.org) for the growth and advancement of freestanding birth centers.
- Reorganized management practices enabling birth center to pay off incurred debt (over 12% of gross income), in the first year employed with Best Start Birth Center, while maintaining quality clinical/ personnel services.

Karen Roslie: Letter of Interest

Executive Director of Best Start Birth Center in San Diego, CA. Born and raised in coastal areas of San Diego, California. Graduate of Cal State San Marcos in field of Social Science/Psychology.

My mother is Roberta Frank, a Certified Nurse Midwife, and founder of Best Start Birth Center, incorporated in 1989. Best Start Birth Center was California's first state licensed and nationally accredited birth center.

Prior to my employment at Best Start Birth Center, I enjoyed a successful career in real estate and had no plans to make a career change. However, after the birth of my son, born at Best Start Birth Center in 2003, I experienced midwifery care firsthand and when a vacancy opened at Best Start in February of 2007, I stepped in to fill it. While I knew nothing about the medical field, I did have the skills needed to run the non-clinical aspects of the organization. I have been with Best Start, ever since.

Unfortunately, as of April of 2024, we were forced to close Best Start Birth Center due to midwifery staffing issues. The number of qualified midwives available is inadequate to meet patient demand. Midwife education has not kept up with the need, and existing midwives cannot be credentialed in a timely manner. Conflicting regulations at state and federal levels contribute further to midwives being underutilized.

Both midwifery license types, (Licensed Midwives and Certified Nurse Midwives), provide excellent care for low-risk pregnancies and need to be able to practice to their fullest potential. Especially during a time when obstetric practices and birth centers are closing all over the state, community midwives are going to be utilized by the public in home birth settings more than ever. My hope is that policy changes will enable the healthcare system to support the desire of pregnant people to receive midwifery care, if desired. If community midwives were fully accepted, midwifery care could provide a solution to issues within our maternal healthcare system, such as racial disparities and providing care in areas that lack obstetric providers.

Disclosure: I previously served as a consumer member for the Midwifery Advisory Committee for the Board of Registered Nursing from November 2015 to January 2020. My personal experience as both a consumer of midwifery care as well as an operations director of a California licensed and nationally accredited birth center, qualify me to fulfill the role of Midwifery Advisory Council Member for Board of Medicine. 
