SUBJECT: Health Care Professions: Deceptive Terms or Letters:

Artificial Intelligence

SPONSOR: SEIU California and California Medical Association

POSITION: Support

DESCRIPTION OF CURRENT LEGISLATION:

Prohibits artificial intelligence systems or similar technologies from misrepresenting "themselves" as licensed health professionals.

AB 489 was not amended after the previous meeting of the Medical Board of California (Board).

IMPLEMENTATION TASKS:

- Report in the Board's newsletter (expected to be published by January 2026).
- Collaborate with the Department of Consumer Affairs, as needed, to create an enforcement code to track associated complaints (expected to be completed in January 2026).
- Publish a newsletter article in 2026 to highlight awareness of this law.

BACKGROUND:

<u>Business and Professions Code (BPC) section 125.5</u> authorizes a board within the Department of Consumer Affairs (DCA), with the approval of the DCA director, to request that the relevant superior court enjoin a person who has engaged or is about to engage in any act that would violate the law administered by that board.

Within the Medical Practice Act, BPC sections <u>2052</u> and <u>2054</u> prohibit an individual from practicing medicine without a license or inappropriately representing that they are a physician (or use related terms/initials like M.D.), respectively. <u>BPC section 2400</u> bars the corporate practice of medicine and states that corporations or other artificial legal entities have no professional rights, privileges, or powers.

Government Code section 11546.45.5 defines artificial intelligence to mean "an engineered or machine-based system that varies in its level of autonomy and that can, for explicit or implicit objectives, infer from the input it receives how to generate outputs that can influence physical or virtual environments."

<u>GC section 11549.64</u> defines "generative artificial intelligence" or "GenAI" to mean an artificial intelligence system that can generate derived synthetic content, including text, images, video, and audio that emulates the structure and characteristics of the system's training data.

ANALYSIS:

According to the author's fact sheet:

"Programs and chatbots powered by artificial intelligence have exploded in popularity. Because AI systems can now produce natural-sounding language, and because these systems are trained on a vast amount of information, including health-related information, they can convincingly mimic a health professional. Without proper safeguards, this capability can pose a danger to consumers in both health and non-health applications, especially to children and individuals with low health and/or digital literacy."

AB 489 extends the enforceability of existing title protections for various licensed health care professions so that a healing arts board may expressly apply them against a person or entity who develops or deploys artificial intelligence technologies that falsely indicate or imply possession of a license to practice a health care profession.

Similarly, it prohibits using these technologies to indicate or imply that the care or advice offered is provided by a natural person in possession of the appropriate license. Each healing arts board would be authorized to take enforcement action for violations of the related practice act (e.g., the Board of Psychology related to impersonations of a licensed psychologist).

The staff of the Board believe that the conduct described in AB 489 is already prohibited by the Medical Practice Act, with respect to the practice of medicine. Accordingly, the Board is already authorized to take enforcement action related to the activity described in the bill.

FISCAL: Minor, one-time costs to create new BreEZe codes to track related

complaints and investigations. The bill highlights inappropriate use of artificial intelligence, possibly leading to an unknown increase in

complaint volume and costs.
