NOTICE IS HEREBY GIVEN that the Medical Board of California (Board) is proposing to adopt section 1352.3 and amend section 1359 of Title 16 of the California Code of Regulations (CCR) relating to Fees for Petitions for Penalty Relief.

These regulations were initially noticed on November 15, 2024. The Board inadvertently delayed posting the Notice, Proposed Text, and Initial Statement of Reasons to its website and mailing and emailing the rulemaking documents to interested parties, which may have caused confusion to individuals seeking to review the documents. The rulemaking documents were posted to the Board's website and mailed to interested parties on November 19, 2024, and emailed to interested parties on November 20, 2024. Therefore, the Board is extending the final date of the public comment period from December 30, 2024, to January 6, 2025.
